The Law Society reserves the right to restrict the number of CPD Freedom places available at any seminar or event.

CPD Freedom members avoid cancellation fees when they cancel attending a seminar in which they have enrolled, but it's important to advise the Law Society of non-attendance at the earliest opportunity. CPD Freedom members can now cancel seminars online by logging into their Member Dashboard via the Law Society Website (<https://members.lawsocietywa.asn.au>). Please note that places are limited at some seminars and repeated non-attendance is monitored.

CPD Freedom entitlements and benefits are only accessible in the current CPD year.

CPD Freedom subscription and your Law Society membership must be financial at all times. They cannot be retrospectively claimed, claimed before you have paid your annual Law Society membership subscription, or accessed once your Law Society membership has lapsed.

CPD Freedom is not available on a pro-rata basis, i.e. if a new member joins after a pro-rata membership renewal programme has commenced, they must pay the FULL CPD Freedom cost for the membership year it applies to and CPD Freedom is only applicable to the membership year in which it has been acquired.

Members that pay a full year membership may at any time pay the full additional cost of CPD Freedom to “upgrade” their membership to include CPD Freedom.

CPD Freedom members are required to request their eLearning Discount code from the CPD Team at the Law Society once they have created an account on the eLearning Portal. The Law Society will not be held responsible if the Discount Code is not used and full price is charged. Refunds will not be granted in these circumstances.

Please be advised that a processing time for your application will apply and you will not have immediate access to the CPD Freedom discount should you be registering outside of our standard operating hours, Monday to Friday, 8.30am – 5.00pm. Once your application has been processed, you will receive an email providing you details on how to access your CPD Freedom benefits, including how to obtain a specific discount code for eLearning. You are required to use this code each time you access a new seminar from the eLearning portal.
